General Terms and Conditions of Participation

(hereinafter "the Terms") in the event

1. General information

- 1.1 The present general terms and conditions apply to participation and related sale of admission tickets to the above-mentioned event organised by the above-mentioned Organiser. Varying terms and conditions of participants do not apply.
- 1.2 The Organiser reserves the right to amend the present rules. Potential amendments become effective by publishing on the websites mentioned bellow.

2. Registration and entering into agreement

2.1 Registration to participation in the event is only possible through the registration form published at the website of the 21st Tactical Air Force Base Čáslav:

- 2.2 For the provision of service, it is required to correctly fill in and send all data required in the registration from, accept the Terms and pay the relevant amount using an on-line payment. The Participants are obliged to check correctness and completeness of the data filled in the registration form. By registering, the Participant consent with their inclusion in the Organiser's database and can be informed about similar events in the future.
- 2.3 The agreement on participation in the event is concluded with the notification in writing to the Participants by the Organiser of their registration and the receipt of the payment using the following e-mail address:

Amendments to the present agreement must be done in writing. That also applies to the cancellation of the clause on the written form.

3. Price

- 3.1 The stated price of participation is a final price that is binding for the Participants.
- 3.2 The Participants will receive adequate value for the price of participation. It involves a welcome pack that comprises tokens of remembrance with the logo of the exercise and small refreshments.

4. Payment

- 4.1 The payment of the participant fee is done by wire transfer to the bank account of the Association: 131-1914500217/0100. The fee is payable upon registration and the payment is required to be remitted with stating the name and surname of the Participant in the message for the payment recipient.
- 4.2 If the payment is not remitted within 7 days from the registration, the organiser is entitled to withdraw from the agreement. The Participant thus ceases to be entitled to participate in the event. New registrations are possible as per free capacity.

5. Personal data and data security

- 5.1 For the purposes of the event, the Association processes the data on the participants, particularly the name and surname of persons and their email addresses provided voluntarily, and processes that data solely to the effect of the person's identification and application to the event named "Spotters Day Lion Effort 2024" in accordance with the Act No. 110/2019 Coll., on Personal Data Processing, as amended, and with the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/ES (GDPR). For the purposes of the event, registering of the person's personal data is processed by the Association, e-mail: spolek21ztl@gmail.com. The person's withdrawal in the course of the contest or recalling of their provided consent automatically deletes the personal data of the persons.
- 5.2 The Organiser does not bear the responsibility for potential unauthorised actions by third persons, as a result of which the third persons gain unauthorised access to personal data of individual customers and/or to relevant data storage, when the third persons use, misuse, abuse the data or make them accessible to third parties in an unauthorised manner. The Participant declares that the Participant is aware of the risks ensuing from those unauthorised actions by third persons.

6. Withdrawal

Should the Participant not wish to participate in the event, the Participant is obliged to notify the withdrawal to the Organiser by email message to: spolek21ztl@gmail.com within 14 days from entering into agreement.

7. Services and conditions of the location of the event

- 7.1 The scope of performance under the agreement in the frame of the event ensues from information documents, information on the event's website, available registration forms and confirmation of participation by the Organiser. In case of discrepancies and in any case, the description of services in the confirmation of the reservation prevails.
- 7.2 By presenting the confirmation of registration on entry to the location of the event, the holders of the admission ticket express their consent to the operating policy of the event's location, instructions by the Organiser's, service personnel of the 21st Tactical Air Force Base Čáslav and Military Police and with the associated terms and conditions.
- 7.3 Participants are explicitly prohibited to bring into the premises of the 21st Tactical Air Force Base Čáslav arms, explosives, flammables, pyrotechnics and objects for threats and acts of violence.

- 7.4 Russian or Byelorussian nationals possibly interested in participating in the event will not be allowed to participate in the event.
- 7.5 The Association is not in the position to guarantee the presence of all previously declared air assets in the course of the event.

8. Cancellation or change of the event's timing

- 8.1 Because of urgent reasons, the Organiser may cancel the event at short notice or change the timeframe of the event, especially because of force majeure (weather conditions, epidemics, terrorist attacks, diseases, strikes etc.) or as a result of the Organiser's decision for reasons of prevention.
- 8.2. In case of the event's cancellation, the Organiser will return the remitted payment within 14 days after deducting the price of the welcome pack. The Organiser will proceed in the same manner in case of withdrawal. The welcome packs will be available after previous arrangement in the premises of the 21st Tactical Air Force Čáslav. The Participants will not be reimbursed for potential additional costs incurred.
- 8.3 In case the Organiser has information about cancellation or changing the event's timeframe, the Organiser will publish the information without undue delay on the website of the 21st Tactical Air Force Base and on Facebook. The Organiser will not provide any substitute performance to the customer for lost time or lost earnings and the like, which will be caused by non-holding of the event or change of its timeframe.

9. Visual and sound recordings
